Rules for Snow Tubing

1. Supervision by High Braes Refuge staff is **required** for use of all tube runs. Runs are not to be used unless Braes personnel are present at the run.
2. Do not walk up the tube runs. Walk up the hill where designated.
3. One person to a tube maximum.
4. The length of tube trains will be determined by Braes staff. Train size may be limited depending on run and weather conditions.
5. You may only ride sitting down on the tubes. Tubes are not to be stacked.
6. Tubing is only permitted on designated tube runs which have been prepared for your safety. Modifying runs is not permitted.
7. No throwing snow into the tube runs or at people coming down runs.
8. Tubes are to be obtained outside the barn and returned to that location when finished. Tubes should be turned over when left outside.
9. You are tubing at your own risk.
10. Those individuals who choose not to follow these rules or are found interfering with other tubers will not be allowed to continue tubing.

Ice Skating Rink Rules

1. Weather and condition permitting, the ice rink will be open from 10:00 am to 11:00pm each day. Signs will be posted if the rink is closed during times of maintenance.
2. Skates are not required to use the rink and groups are welcome to use it with boots only.
3. All skating must be supervised by an adult leader.
4. Braes staff have the right to disallow any activity on the ice rink they find inappropriate or risky.
5. Lights must be turned on for night tubing.
